## C. Reports

Superintendent's Report=Chairman Davis thanked Mr. Shafer for all the great work he did for the school. On behalf of the board Director James Hartung presented Mr. Shafer with a resolution recognizing his contributions and time he has given to the Maritime Academy of Toledo. 5th Grade 60%, 6th Grade 71%, 7th Grade 62%, 8th Grade 85%, 9th Grade 87% and 10-12th Grades 95%. The percent of students who were contacted were Grades 5-9 100%, 10-12 97%. Director Stacy commented we should feel good about these figures.
